News from APS

IMPORTANT NEWS ABOUT YOUR BILL

At APS we are committed to communicating changes that might affect you. Effective January 01, 2012, the Arizona Corporation Commission approved the Company's request to reduce the System Benefits Charge ("SBC") which will be shown as a separate line item on the bill called the System Benefits Adjustment ("adjustment"). This temporary adjustment will reduce the SBC charge for customers on the Company's E-3 limited-income rate from \$0.00185/kWh to \$0.00160/kWh. The SBC for all other customers will be reduced from \$0.00210/kWh to \$0.00185/kWh. The reduction came about as a result of the Nuclear Regulatory Commission (NRC) renewing the operating license for Palo Verde Units 1, 2 & 3.

For general service customers with 20 kW or less using 1,430 kWh per month, this temporary adjustment will decrease their monthly bill by approximately 0.17% or by \$0.36 per month. General Service customers with greater than 20 kW will see a decrease of 0.25% or by \$15.56 per month based on an average monthly energy consumption of 62,238 kWh. All bills for utility services are due and payable no later than 15 days from the date of the bill. Any payments not received within this time-frame shall be considered delinquent and are subject to a late payment charge of 1.5% per month.

If your power is shut off for non-payment, you must pay all the delinquent amounts and a deposit or additional deposit before power is restored.

When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic funds transfer from your account or to process the payment as a check transaction. When we process your check electronically you will not receive your check back from your financial institution and funds may be withdrawn from your account on the same day we receive your payment.
