IMPORTANT NEWS ABOUT YOUR BILL

At APS we are committed to communicating changes that might affect you. On June 21, 2011, the Arizona Corporation Commission confirmed a change in the Federal Transmission Cost Adjustor (TCA) charge previously authorized by the Federal Energy Regulatory Commission. This is shown as a separate line item on your bill. The change more accurately reflects the current costs that APS incurs in providing transmission service to its customers. For residential customers using 1,100 kWh per month, this will increase their monthly bill by approximately 1.79% or \$2.27 per month. All bills for utility services are due and payable no later than 15 days from the date of the bill. Any payments not received within this timeframe shall be considered delinquent and are subject to a late payment charge of 1.5% per month.

If your power is shut off for non-payment, you must pay all the delinguent amounts and a deposit or additional deposit before power is restored.

When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic funds transfer from your account or to process the payment as a check transaction. When we process your check electronically you will not receive your check back from your financial institution and funds may be withdrawn from your account on the same day we receive your payment.
