Adjustor Changes on Your Bill Beginning February 2013

In January, the Arizona Corporation Commission (ACC) approved two changes to your APS bill which will take effect in February 2013.

The first is for the Power Supply Adjustor (PSA) which is for fuel and purchased power costs. The PSA increased by \$0.005507/kWh. The second is for the Renewable Energy Standard Adjustment (REAC) which is for renewable energy projects, and is included in the Environmental Benefits Surcharge (EBS) on your bill. The REAC increased by \$0.002613/kWh to \$0.009575/kWh with a cap of \$3.83 per month.

Based on average energy use of 1,100 kilowatt hours per month, these fees will increase a typical bill by approximately \$6.00 and \$1.00, respectively. All bills for utility services are due and payable no later than 15 days from the date of the bill. Any payments not received within this time-frame shall be considered delinquent and are subject to a late payment charge of 1.5% per month.

If your power is shut off for non-payment, you must pay all the delinquent amounts and a deposit or additional deposit before power is restored.

When you provide a check as payment, you authorize us either to use information from your check to make a one-time electronic funds transfer from your account or to process the payment as a check transaction. When we process your check electronically you will not receive your check back from your financial institution and funds may be withdrawn from your account on the same day we receive your payment.








